# **COOKIES POLICY**

Cookies are used on the Website. This term refers to small text files that the sites visited by the user send to the user's terminal (usually the browser), where they are stored and then sent back to the same sites the next time the user visits them.

They are used to improve the functionality of the site, allow the user to move easily between pages, remember his preferences and to ensure always optimal navigation.

Cookies may have different nature and duration. In particular, they can be "persistent" and remain stored until they expire, or they can be "session" ones and then automatically disappear when the browser is closed.

# **TECHNICAL COOKIES**

Cookies of this type are necessary for the proper operation of certain areas of the site. They can be divided into navigation or session cookies, which guarantee normal navigation and use of the website (allowing, for example, to make a purchase or log in to access reserved areas). Without these cookies, the website or parts of it may not function properly. Therefore, they are always used, regardless of user preferences. Because of their nature, disabling or deleting them, which is generally allowed by accessing the functions of your browser, could compromise the optimal navigation on this website. The use of these cookies does not require the user's consent. This site uses both persistent and session technical cookies.

### **ANALYTIC COOKIES**

These cookies have been assimilated by Provisions from the Supervisory Authority to technical cookies, in the event that they are used directly by the website manager to collect information, in aggregate and anonymous form, on the number of users and how they visit the website. Also in this case the prior consent of the users is not necessary.

# **FUNCTIONALITY COOKIES**

Functionality cookies allow the user to navigate according to a number of selected criteria (for example, language, products selected for purchase) in order to improve the service provided.



This type of cookie has also been assimilated by the Supervisory Authority to technical cookies, which do not require prior consent from the user.

### PROFILING COOKIES

They are used to create user profiles (analysis of consumer behaviour and habits to customise the commercial offer of services and products of possible interest to the user) in order to send advertising messages in line with the preferences expressed during the navigation.

The use of these cookies, unlike the previous ones, requires the acquisition of the prior consent of the user, obtained through banners displayed at the first opening of the site. This site does not use profiling cookies

# THIRD-PARTY COOKIES

While navigating the website, the users may then receive also cookies from different websites or web servers (so-called "Third party cookies") on their terminal: this happens because there may be elements on the site such as, for example, images, maps, sounds, specific links to web pages of other domains (such as social networks) that reside on servers other than those used by the Data Controller. In other words, these cookies are set directly by operators of websites or servers other than the one you are currently visiting.

The use of third-party cookies can normally be inhibited by the user also through the appropriate option in your browser: see the above indications. The Site uses Google Analytics, a web traffic analysis service provided by Google, Inc. ("Google"). This service is used to collect statistical data that allow us to improve the experience of website users. Google Analytics uses "cookies" to collect and analyse information about how users interact with the website in aggregate form (e.g. most visited pages, geographical origin of visitors, etc.). Google stores the information collected on its servers in the United States.
