

## **PRIVACY NOTICE PURSUANT TO ART. 13 OF THE GENERAL DATA PROTECTION REGULATION (GDPR), EU Regulation no. 2016/679**

This page describes how the personal data of users who consult the website of AGENZIA MARITTIMA DE FELICE Srl are processed.

This information does not concern other sites, pages or services that can also be reached through hypertext links that may be published on the website but refer to resources outside the domain of AGENZIA MARITTIMA DE FELICE Srl.

### **DATA CONTROLLER**

The Data Controller for the purposes of the GDPR is AGENZIA MARITTIMA DE FELICE Srl, with registered office in Via Coppino, 433, 55049, Viareggio (LU), Italy

### **PROCESSED DATA AND PROCESSING PURPOSES**

#### *Navigation data*

During their normal operation the computer systems and software procedures used to operate this website acquire some personal data whose transmission is implicit in the use of Internet communication protocols.

This category of data includes IP addresses or domain names of computers and terminals used by users, URI/URL (Uniform Resource Identifier/Locator) of requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response from the server (successful, error, etc.) and other parameters relating to the operating system and computer environment.

These data, necessary for the use of web services, are also processed for the purpose of:

- obtain statistical information on the use of the services (most visited pages, number of visitors per time slot or day, geographical areas of origin, etc.);
- check the correct operation of the services offered.

The navigation data do not persist for more than seven days and are deleted immediately after their aggregation (except for any need to ascertain crimes by the judicial authority).

For this type of processing, the purpose is exclusively to allow the functionality of the site. The legal basis of the data processing is therefore to allow the data subject/visitor to explore the website of AGENZIA MARITTIMA DE FELICE Srl

#### *Data provided by the user*

This site allows direct interaction with the visitor who fills in and sends us the contact form available on the website.

The contact details consist of the following personal data: name, surname, e-mail address and telephone number.

These data are processed exclusively for the purpose of responding to requests received by the user, whose legal basis is art. 6, par. 1, letter a), as to the consent given by the data

subject to the processing of their personal data for one or more specific purposes, and letter b), as to the need to process the data provided to respond to requests, including pre-contractual requests, made by the data subject by filling and transmitting the contact form. The retention period of the data acquired through the contact form is two years. Consent may be revoked at any time.

#### *Cookies and other tracking systems*

Cookies are not used for user profiling, nor are other methods of tracking used.

Instead, session cookies (not persistent) are used in a manner strictly limited to what is necessary for the secure and efficient navigation of the websites. The storage of session cookies in terminals or browsers is under the control of the user, whereas at the end of HTTP sessions, on the servers, information relating to cookies remain recorded in the service logs, with retention time not exceeding seven days as other navigation data.

#### **DATA RECIPIENTS**

Access to data collected following consultation of the website of AGENZIA MARITTIMA DE FELICE Srl, is only allowed for those in charge of data processing, who act on the basis of specific instructions provided in relation to the purposes and methods of the processing itself, and any data processors appointed pursuant to art. 28 *et seq.* of the GDPR.

#### **DATA SUBJECT'S RIGHTS**

Pursuant to art. 15 *et seq.* of the GDPR, the interested parties have the right to obtain from the Data Controller, in the cases provided for, access to personal data, rectification where the data are inaccurate, their portability, or even their cancellation in the absence of their legal basis or when their legal basis is no longer applicable.

Data subjects may also request the limitation of processing for the cases provided for in article 17 of the GDPR or oppose processing of their personal data in the cases provided for in article 21 of the GDPR, unless legitimate reasons exist for the Data Controller not to do so.
